1. THAT THE EVENT IS RELATED TO A NATIONAL, STATE, REGIONAL OR LOCAL FUNCTION OR CHARITABLE AFFAIR;
2. NO MORE THAN TWENTY PERCENT (20%) OF THE MESSAGE RELATES TO NAMING OR ADVERTISING A COMMERCIAL PRODUCT, ENTERPRISE, BUSINESS OR COMPANY REGARDLESS OF WHETHER THEY ARE SPONSORING THE EVENT OR BANNER INSTALLATION;
3. TRAFFIC CONTROL WILL BE PERFORMED IN ACCORDANCE WITH THE MOST CURRENT PENNSYLVANIA DEPARTMENT OF TRANSPORTATION PUBLICATION 203;
4. VERTICAL CLEARANCE ABOVE THE ROAD MUST BE MINIMUM 17'6" AND THE BANNER IS NOT BEING PLACED OVER OR IN THE RIGHT-OF-WAY OF AN EXPRESSWAY, FREEWAY OR INTERSTATE HIGHWAY;
5. **THE BANNER WILL NOT BE DISPLAYED FOR A PERIOD THAT EXCEEDS 14 DAYS AND WILL BE REMOVED WITHIN 1 DAY FROM THE ENDING OF THE EVENT.**
